CONSEQUENCES OF ADMISSION:		
10. I understand that the possible consequences for contempt include the following FOR EACH COUNT: First finding of contempt: Up to 120 hours community service, or up to 120 hours (5 days) jail. Second finding of contempt: Up to 120 hours community service, and/or up to 120 hours (5 days) jail, and a fine of up to \$2,700 (\$1,000 plus penalty assessments.) Third finding of contempt: Up to 240 hours community service, up to 240 hours (10 days) jail, and pay an administrative fee that covers the cost of supervision by the community service program (not to exceed the actual supervisorial and administrative cost). Per CCP '1218(c)(4), the court will take the parties' employment schedules into account when ordering imprisonment or community service.	10.
